What is the Program Area?

What is the Process?

- ~ Obtain pre-approval for loan
- ~ Complete full Housing application
- Work with YCDC and local realtors to find a qualified house or select prequalified home.
- ~ Notify SENDD when you find a home that you are interested in buying
- \sim Inspection completed by SENDD
- ~ City acquires home
- ~ Rehab coordinated by SENDD (can be up to \$24,999) and approved by applicant
- ~ Rehab costs added to Acquisition price
- ~ Home is sold to you and down payment assistance is provided

Our Housing Managers and staff are available to you throughout the process.

What is the deadline?

Qualified applicants will be considered on a ready to close basis. Once apportioned funds used, applications will not be accepted so start now!

Will I have to pay the down

payment assistance back? Yes,

this is a non-forgivable, non-interest bearing loan for the life of home occupancy, eligible to qualified applicant.

Requirements

~ Annual household income cannot

exceed the HUD guidelines established.

- ~ Applicant must be prepared to put up to \$1,000 earnest money down for the purchase agreement.
- ~ Need to obtain a mortgage loan from a lender of your choice.
- ~ Must reside in home as your primary residence during the life of the down payment assistance loan.

What repairs are ELIGIBLE?

- ~ Structural-Foundation, Roof, etc.
- ~ HVAC Systems
- ~ Gutters
- ~ Water Heater
- ~ Electrical-Wiring, fuse boxes
- ~ Plumbing
- ~ Weatherization
- ~ General Maintenance
- ~ Handicapped Accessibility
- ~ Relieve overcrowding
- ~ Safety and Code Deficiencies

What is usually not eligible?

- ~ Garages & Outbuildings
- ~ Window Air Conditioning Unit
- ~ Fireplaces
- ~ Jacuzzis, hot tubs and spas
- ~ Kitchen Appliances
- Any costs for repairs not completed in the program.
